



NFT SALES TERMS AND CONDITIONS

These “Terms and Conditions” last material update was made on: February 8, 2022.

The NFT Platform JAADOO.io allows you to participate, by creating, displaying, buying, and selling non-fungible tokens (“NFTs”) and is made available to you by Jaadoo -NxGen Digital Company.

1. Acceptance

By clicking the “Sign Up” button, completing the account registration process and using the NxGen Digital – Jaadoo.io, you confirm that you understand and agree to these terms and conditions, together with any documents that may be expressly referred to and are incorporated by reference (“Terms”).

These Terms constitute a legal agreement between you and Jaadoo.io and govern your access to and use of the NxGen Digital – Jaadoo.io, including any content, functionality, and services offered on or through Jaadoo.io/NFT (the “Site”).

Jaadoo.io reserves the right to change or modify these terms at any time and at our sole discretion. You agree and understand that by accessing or using the Jaadoo.io and the Site following any change to these Terms, you are regarded as having agreed to the revised Terms.

2. Definitions

In these Terms:

“Non-fungible token” “NFT”: Non-fungible token is a commercial term to describe items like your furniture, a picture image file, or your laptop. These things are not interchangeable for other items because they have unique properties. NFTs are tokens that we can use to represent ownership of unique items. They let us tokenize things like art, collectibles, even real estate. They can only have one official owner at a time and they're secured by the Ethereum blockchain – no one can modify the record of ownership or copy/paste a new NFT into existence.

“Fungible items”: on the other hand, can be exchanged because their value defines them rather than their unique properties. For example, ETH or dollars are fungible because 0.1 ETH / \$1 USD is exchangeable for another 0.1 ETH / \$1 USD.

“Applicable Law”: any law, rule, statute, subordinate legislation, regulation, by-law order, ordinance, protocol, code, guideline, treaty, policy, notice, direction or judicial, arbitral, administrative, ministerial or departmental judgment, award, decree, treaty, directive, or other requirement or guideline published or in force at any time which applies to or is otherwise intended to govern or regulate any person (including all parties to this Terms), property, transaction, activity, event or other matter,

including any rule, order, judgment, directive or other requirement or guideline issued by any governmental or regulatory authority;

“Sale Item” means any one or more of the following without limitation:

(a) any art (including without limitation, designs, drawings, prints, images in any form or media, including without limitation videos and photographs);

(b) audio files;

(c) collectibles;

(d) memorabilia;

(e) game assets.

"we/us/our" means Jaadoo.io.

"you/your" means the user of the Jaadoo.io .

3. Eligibility

Jaadoo.io has sole and absolute discretion to allow or disallow your access to the Jaadoo.io.

By agreeing to these Terms, you represent and warrant that:

(i) You are at least 18 years of age;

(ii) You have the full right, power, and authority to agree to these Terms;

(iii) You are not subject to any financial sanctions, embargoes or other restrictive measures imposed by the United Nations, European Union, any EU country, UK Treasury or US Office of Foreign Assets Control (OFAC), or any governmental authority in any jurisdiction in which the Jaadoo.io is available.

(iv) You are not a citizen or resident of any of the following countries: *Belarus, Central African Republic, Cote d'Ivoire (Ivory Coast), Cuba, Democratic Republic of the Congo, Iran, Iraq, Lebanon, Liberia, Libya, Myanmar (Burma), North Korea, Somalia, Sudan, Syria, Zimbabwe.*

(v) You are not impersonating any other person;

(vi) You will not use the Jaadoo.io if any Applicable Laws in your country prohibit you from doing so in accordance with these Terms.

(vii) You are compliant with all Applicable Laws to which you are subject;

(viii) You have read, understood and agreed to our Privacy Notice and Cookie Policy.

4. Jaadoo.io Account

You must create an account (“Account”) to use the Jaadoo.io. To create an account, we will require you to provide certain information about yourself and we may, in our sole discretion, require you to provide further information and/or documents at any stage during your use of the Jaadoo.io Platform. We may, in our sole discretion, refuse, decline, suspend or disable your access or use of the Jaadoo.io.

5. Changes to the Jaadoo.io

We may in our absolute and sole discretion change, update, amend, remove, or discontinue any part of the Site, the services and the Content at any time without prior notice to you.

6. Fees

By buying and selling NFTs, including through the Auction process, on the NxGen Digital – Jaadoo.io, you agree to pay all applicable fees as stipulated in the FAQ and on the checkout screen at the time of your purchase. You authorize Jaadoo.io to automatically deduct fees directly from payments to you and/ or add fees to your payments to Jaadoo.io where applicable.

7. Your Use of the Jaadoo.io and Conduct

We hereby grant you a limited, non-exclusive, non-transferable, revocable license to access and use the Site and Content. Our grant of such license is subject to the following conditions. You undertake not to (and shall not, knowingly or otherwise, authorize, allow or assist any other party to):

(i) Use the NxGen Digital – Jaadoo.io, Site, or your Account to conduct electronic spamming or otherwise distribute any unsolicited or unauthorized advertising, promotional or marketing material, junk or chain messages.

(ii) Use the NxGen Digital – Jaadoo.io, Site, or your Account to perform unlawful activities that violates any Applicable Laws (including but not limited to money laundering, terrorism financing and/or fraudulent activities) or immoral activities.

(iii) Use the NxGen Digital – Jaadoo.io, Site, or your Account to engage in any activity which operates to defraud Jaadoo.io, other users, or any other person, or to provide any false, inaccurate, or misleading information to Jaadoo.io.

(v) Modify or adapt the whole or any part of the NxGen Digital – Jaadoo.io, and Site or incorporate the Site into any other program or application.

(vi) Disassemble, decompile, reverse-engineer or otherwise attempt to derive the source code, object code, underlying concepts, ideas and algorithms of the Site or any components thereof;

(vii) Use the NxGen Digital – Jaadoo.io, Site, or your Account in any manner that would lead to infringement of our, our Affiliates' or any third party's intellectual property rights, including without limitation any copyright, patent, or trademark. You undertake not to take or attempt to take any action or claim ownership of any property that infringes or would infringe upon our intellectual property interests;

(viii) Use the NxGen Digital – Jaadoo.io Site, or your Account in a way that could damage, disable, impair, or compromise the Site or the provision of the NxGen Digital – Jaadoo.io or interfere with other users or affect the reputation of NxGen Digital – Jaadoo.io

(ix) To take any action to gain or attempt to gain unauthorized access to the account or wallets of other users.

(x) Take any action that imposes an unreasonable or disproportionately large burden or load on the Jaadoo.io infrastructure (including, but without limitation to our servers, networks, data centres and related or like equipment) and detrimentally interfere with, intercept, or expropriate any system, data or information belonging to other users of the NxGen Digital – Jaadoo.io

(xi) Engage in any other activities deemed inappropriate by us or which is in contravention of these Terms or any Applicable Laws.

(xii) Provide false, inaccurate, incomplete, or misleading information to NxGen Digital – Jaadoo.io or any of its Affiliates or third-party services providers; and/or

(xiii) Use the NxGen Digital – Jaadoo.io, Site, or your Account to engage in any lottery, bidding fee auctions, contests, sweepstakes, or other games of chance.

8. User Content

The NxGen Digital – Jaadoo.io allows (i) users to create a profile where they can post information about themselves, display their NFTs, and sell NFTs they own (ii) artists or creators of NFTs (“Creator”) to put their NFTs up for sale (which may be via auction (“Auction”, please refer to clause 9 for more information) (together the “User Content”).

Any information you post on the Site as a Creator will be considered non-confidential. By providing any User Content on the Site, you grant us and our affiliates and our respective licensees, successors, and assigns the right to use, reproduce, modify, perform, display, distribute, retransmit, publish, broadcast, and otherwise disclose to third parties any such material for any purpose. You represent and warrant that (1) you own and control all rights in and to your User Content and have the right to grant such licenses to us and our affiliates and our respective licensees, successors, and assigns; and

(2) all of your User Content do and will comply with these Terms.

You understand and agree that you are responsible for any User Content you submit or contribute, and you, and not NxGen Digital – Jaadoo.io have full responsibility for such content, including its legality, reliability, accuracy, and appropriateness. We are not responsible or liable to any third party for the content, accuracy, or appropriateness of any User Content posted by you or any other user on the Site.

If you are a Creator, you hereby grant NxGen Digital – Jaadoo.io the right to use your name and image for marketing or promotional purposes and agree that we may use or modify images from the NFTs that you create for marketing or promotional purposes. You also agree that we can use your biography and other public information about you to promote the NFTs that you create.

If you are a Creator, you agree that you will not infringe on the intellectual property of others and will not coordinate pricing of any NFTs with other Creators.

We reserve the right, in our absolute sole discretion, to prohibit you from uploading any NFTs to the Site. We are not required to monitor any User Content, but we may in our sole discretion, remove any User Content at any time and for any reason without notice. NxGen Digital – Jaadoo.io may monitor the User Content to detect and prevent fraudulent activity or violation of these Terms.

9. Intellectual Property

Unless otherwise indicated by us, and except to the extent of the User Content, the Site, all content, and other materials contained therein, including, without limitation, the Jaadoo logo, and all designs, text graphics, pictures, information, data, software, and files relating to NxGen Digital – Jaadoo.io (the “Content”) are the proprietary property of NxGen Digital – Jaadoo.io or our affiliates, licensors, or users, as applicable.

NxGen Digital – Jaadoo.io may pause, cancel, or discontinue your Auction transactions at its sole discretion without liability.

11. Your Ownership of the NFT

Apart from the Content, all other copyrights, trademarks, product names, and logos on the Site relating to and including the NFTs and User Content, are the property of their respective owners and may not be copied, imitated, or used, in whole or in part, without the permission of the applicable intellectual property right owner.

When you buy an NFT on the NxGen Digital – Jaadoo.io you own the NFT and have the right to sell or give away the NFT. 12. Data Protection / Privacy

We reserve the right at any time to satisfy our internal requirement as to your Personal Data (for example, by requesting relevant original documents) including for the purposes of preventing fraud and/or anti-money laundering and counter-terrorist financing purposes.

13. Limitation of Services / Account Closure / Termination

We reserve the right, without notice and in our sole discretion, to terminate or suspend your access to or use of the Site and any Content and/or close your Account, at any time for any reason but in particular, if we suspect in our sole discretion that

- (i) your Account is being used for illegal activity;
- (ii) you have concealed or provided false information;
- (iii) you have engaged in fraudulent activity; and/or (iv) you have engaged in activity in violation of these Terms.

If Jaadoo.io is holding funds in your Account and has no record of your use of the NxGen Digital – Jaadoo.io for several years, we may be required, upon passage of applicable time periods, to report these funds as unclaimed property in accordance with the abandoned property and escheat laws. If this occurs, we will use reasonable efforts to give you written notice. If you fail to respond within seven business days or the period as required by Applicable Law, we may be required to deliver any such funds to the applicable jurisdiction as unclaimed property. We reserve the right to deduct a reasonable administrative fee from such unclaimed funds, as permitted by Applicable Law.

14. Risks

- (vii) NFTs are subject to the risk of fraud, counterfeiting, cyber-attacks and other technological difficulties which may prevent access to or use of your NFTs.

You understand and agree that you are solely responsible for determining the nature, potential value, suitability, and appropriateness of these risks for yourself. These Terms constitute the entire agreement between the parties regarding its subject matter and supersedes and invalidates all other prior representations, arrangements, understandings, and

These Terms are concluded in the English language and all communications including any notices or information being transmitted shall be in English. In the event that these Terms or any part of it is translated (for any proceedings, for your convenience or otherwise) into any other language, the English language text of these Terms shall prevail.

23. Waiver

These Terms shall not be waived in whole or in part except where agreed by the parties in writing.

The delay of enforcement or the non-enforcement of any of the terms of these Terms by any party shall not be construed as a waiver of any of the other rights of that party arising out of the breach or any subsequent breach of any of these Terms and no right, power or remedy conferred upon or reserved for any party in these Terms is exclusive of any other right, power or remedy available to that party and each such right, power or remedy shall be cumulative.

24. Notices and Communications

By using the Jaadoo.io NFT Platform you agree that we may provide you with notices or other communications, including marketing, relating to your use of the Jaadoo.io electronically: (a) via email (in each case to the address that you provide), SMS message, or telephone call (in each case to the phone number that you provide), or (b) by posting to the Site. For notices made by email, the date of receipt will be deemed the date on which such notice is transmitted. You will always be given the option to unsubscribe from receiving any marketing material from us.

25. Third Party Rights

Other than the entities within the NxGen Digital group, a person who is not a party to these Terms has no right to enforce any of these Terms.

26. Governing Law and Jurisdiction

These Terms are governed by and shall be construed in accordance with the laws of Singapore without regard to any choice or conflict of laws rules. Any dispute, controversy, or claim, whether contractual or non-contractual, arising out of or in connection with these Terms, or the breach, termination or invalidity thereof, or any other issue which shall arise in virtue of these Terms, shall be referred to and

finally settled by arbitration administered by the Singapore Arbitration/court under the Rules in force when the Notice of Arbitration is submitted.

The law of this arbitration clause shall be Singapore law. The seat of arbitration shall be in Singapore. The number of arbitrators shall be one. The arbitration proceedings shall be conducted in the English language.
